The discount rate used to determine the present value is a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability. The increase in the provision due to the passage of time is recognised as interest expense.

#### 1.6 Revenue Recognition

Revenue is measured at the fair value of the consideration received or receivable.

#### Other Income

Interest income comprises interest receivable on funds invested, dividend income, foreign exchange gains and losses. Interest income is recognized in the income statement as it accrues, taking into account the effective yield on the asset. Dividend income is recognized in the income statement on the date the entity's right to receive payments is established.

Claims receivable is accounted on accrual basis to the extent considered receivable,
